**TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—RIVER COURT, LLC, HOPKINS-TIBBETTS BANK PROTECTION PROJECT, PHASE I, AVENUE HOPKINS AND AVENUE TIBBETTS, SANTA CLARITA, CALIFORNIA (NPDES NO. CAG994004, CI—9269)**

Dear Mr. Backer:

In our letter dated May 31, 2007, we informed you that the subject discharge is regulated under Order No. R4-2003-0111, *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, which also serves as your NPDES permit.

On April 5, 2008, you informed Regional Board staff that the discharge from the above-referenced facility has been completed and the subject NPDES permit is no longer needed. Since the NPDES permit is no longer necessary, you requested termination of your coverage under the above-referenced General NPDES permit.

In our July 16, 2010, letter we indicated to you that we are reviewing your request for termination and the compliance history for your facility for any outstanding mandatory minimum penalty (MMP). Regional Board staff has completed its review and determined that no outstanding MMP exist for your facility. Therefore, your permit has been recommended for termination.

On May 16, 2011, Board staff inspected the facility and verified that there is no discharge of groundwater to the storm drain. Since there is no discharge from the site to the storm drain, coverage under Board Order No. R4-2003-0111 for the subject facility is hereby terminated. Please note that if future discharges of groundwater to surface water becomes necessary, you must file a Report of Waste Discharge with this office and obtain Waste Discharge Requirements (WDRs) prior to discharging.



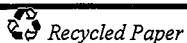
