TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—GRIFFIN INDUSTRIES INC., HERITAGE VALLEY PARK PROJECT, PERMIT G, BETWEEN HIGHWAY 126 AND SANTA CLARA RIVER, FILLMORE, CALIFORNIA (CAG994004, CI—9279)


Dear Ms. Waxman:

In our letter dated October 19, 2006, we informed you that the subject discharge is regulated under Order No. R4-2003-0111, *General NPDES and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, which also serves as your NPDES permit.

On November 13, 2008, you informed Regional Board staff that the above-referenced project was completed on September 7, 2007. Since the NPDES permit is no longer necessary, you requested termination of your coverage under the above-referenced General NPDES permit. On December 2, 2008, our staff inspected the facility and verified that there is no discharge to the storm drain.

Since there is no discharge from the site to the storm drain, coverage under Board Order No. R4-2003-0111 for the subject facility is hereby terminated except for enforcement purposes. Please note that if future discharges of groundwater to surface water becomes necessary, you must file a Report of Waste Discharge with this office and obtain Waste Discharge Requirements (WDRs) prior to discharging any groundwater from the site to surface waters. 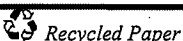
