TERMINATION OF GENERAL WASTE DISCHARGE REQUIREMENTS AT MIRAMAR TREATMENT PLANT, 1021 ESTE MIRAMAR AVENUE, CLAREMONT, CALIFORNIA (ORDER NO. 93-010, Series NO. 030, CI NO. 9290, FILE NO. 07-160)

Dear Mr. Garcia:

In a letter dated September 28, 2007, this Regional Water Quality Control Board (Regional Board) informed the Miramar Treatment Plant (Discharger) that the subject discharge is regulated under General Waste Discharge Order No. 93-010, (Series No. 030), which specifies your Waste Discharge Requirements (WDR) for Miramar Treatment Plant, Facility ID 4B196700030.

In a letter dated February 9, 2009, the Discharger notified the Regional Board that all construction-related discharges have ended. The Discharger requested termination of the WDR.

Regional Board staff conducted the site visit on January 3, 2013, and determined that the Discharger's WDR termination request met the requirements.

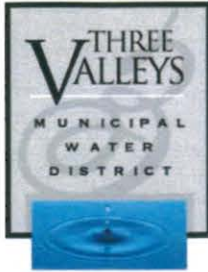
The coverage under Order No. 93-010, (Series No. 030), for the subject facility is hereby terminated with the exception of enforcement under the term of the permit.



Dear Ms. Chou:

Prior to the start of construction in late 2007 of a groundwater production well on its property in Claremont, the Three Valleys Municipal Water District (TVMWD) requested a Waste Discharge permit for incidental and process discharges during construction. The installation of the well was recently completed and all construction-related discharges had ended in mid-2008. Accordingly, TVMWD hereby requests termination of the WDRs and associated permit issued by the LA Regional Water Quality Control Board.

TVMWD recently paid the invoice (Invoice No. 0814581) associated with this permit for the billing period covered by 7/1/08 to 6/30/09.
