TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—BRE/TZ HHL HOLDING, LLC—5901 CENTER DRIVE PROJECT, 5901 CENTER DRIVE, LOS ANGELES, CALIFORNIA (NPDES NO. CAG994004, CI—9413)

Dear Ms. Foyston:

In our letter dated May 9, 2008, we informed you that the subject discharge is regulated under Order No. R4-2008-0032, General NPDES and Waste Discharge Requirements for *Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on June 5, 2008.

On November 1, 2013, you informed Regional Board staff that no groundwater discharge occurred at the above-referenced project site and you requested to terminate coverage under the above-referenced General NPDES permit. Since there is no discharge of groundwater from the project site, coverage under Board Order No. R4-2008-0032, General NPDES Permit No. CAG994004, CI-9413 for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface water becomes necessary, you must file a Report of Waste Discharge with this office and obtain Waste Discharge Requirements (WDRs) prior to discharging any groundwater from the site to surface waters.
