### TERMINATION OF COVERAGE UNDER GENERAL WASTE DISCHARGE REQUIREMENTS AT THE LA HABRA BOOSTER STATION, LOS ANGELES COUNTY, CA (SITE CLEANUP PROGRAM NO. 0018, SITE ID NO. 204H00)

Dear Mr. Defibaugh:

In our letter dated November 30, 2009, we informed you that the subject discharge is regulated under Order No. R4-2007-0019 (Series No. 066), which specifies your Waste Discharge Requirements (WDR).

In a letter dated June 30, 2010, you notified the Regional Board that you ceased the injection of potassium permanganate at the subject site and that you requested termination of the WDR.

Because the ongoing remediation does not plan to continue the injection of potassium permanganate, you no longer need the WDR. The coverage under Board Order No. R4-2007-0019 (Series No. 066), for the subject site is hereby terminated with the exception of enforcement under the term of the permit. Since the request for termination was submitted on June 30, 2010, prior to the end of the fiscal year, you will not be charged the annual fee for the 2010-2011 fiscal year.

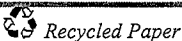
