**TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE  
ELIMINATION SYSTEM PERMIT AND WASTE DISCHARGE REQUIREMENTS—  
CALLEGUAS MUNICIPAL WATER DISTRICT, SALINITY MANAGEMENT PIPELINE PHASE  
1E, HUENEME RD, BETWEEN EDISON AND SURFSIDE DRIVE, PORT HUENEME,  
OXNARD, CALIFORNIA (NPDES NO. CAG994004, CI-9469)**

Dear Ms. Mulligan:

In our letter dated November 21, 2008, we informed you that the subject discharge is regulated under Order No. R4-2008-0032, *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, which also serves as your NPDES permit.


On June 25, 2012, Calleguas Municipal Water District (CMWD) informed the Regional Board that CMWD has completed the subject project and ceased all discharges related to the project during the first quarter of 2012. Since the NPDES permit is no longer necessary, CMWD requested termination of coverage under the above-referenced General NPDES permit.

On August 10, 2012, Regional Board staff inspected the subject project and verified that there is no discharge of groundwater from the project to surface water. Therefore, coverage under Board Order No. R4-2008-0032 for the subject project is hereby terminated, except for enforcement purposes.

Please note that if future discharges of groundwater to surface water or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate Waste Discharge Requirements.
