EXTENSION REQUEST APPROVAL – FORMER ITT CORPORATION HUMBOLDT STREET PROPERTY, 3209 HUMBOLDT STREET, LOS ANGELES, CALIFORNIA (FILE NO. 09-172, ORDER NO. R4-2007-0019, SERIES NO. 155, CI-9652)

Dear Ms. Olmsted:

Reference is made to your letter dated January 3, 2012, requesting time extension to submit the Fourth Quarter 2011 Groundwater Monitoring Report for the former ITT Humboldt Street site located at 3209 Humboldt Street, Los Angeles, California (Site).

On March 11, 2011, the Los Angeles Regional Water Quality Control Board issued Waste Discharge Requirements Order No. R4-2007-0019 (Series No. 155) and a Monitoring and Reporting Program No. CI-9652 for emulsified vegetable oil injection for groundwater remediation at the Site.

Baseline groundwater monitoring activities were originally scheduled for the early part of fourth quarter 2011, but were delayed at the request of the property owner to accommodate the year end import and distribution of goods in the warehouse where most wells are located. As a result, the baseline groundwater monitoring for the Site was performed on December 12 through 21, 2011. An extension for submitting the Fourth Quarter 2011 Groundwater Monitoring Report is therefore needed in order to have time for the Discharger to validate the data and prepare a report.

Based on the above reasoning, an extension is granted for the submittal of the Fourth Quarter 2011 Groundwater Monitoring Report (Report). The revised due date for the Report is February 10, 2012.


