**TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT AND WASTE DISCHARGE REQUIREMENTS—GOLDEN STATE WATER COMPANY—ENCINITA FACILITY, 4836 NORTH ENCINITA AVENUE, TEMPLE CITY (CAG994003, CI-9685)**

Dear Mr. Lewis:

In our letter dated April 26, 2011, we informed you that the subject discharge is regulated under Order No. Order No. R4-2009-0047, *General National Pollutant Discharge Elimination System and Waste Discharge Requirements for Discharges of Nonprocess Wastewater to Surface Waters in Coastal Watersheds in Los Angeles and Ventura Counties*, adopted by this Board on April 2, 2009. We have reviewed your March 2, 2016, letter which requested termination of your coverage under the General NPDES Permit. The letter indicated that project was completed and the permit is no longer needed.

On March 29, 2016, staff inspected the facility and verified that there is no discharge to the storm drain. Since there is no discharge of nonprocess water from the project site, coverage under Board Order No. R4-2009-0047, General NPDES Permit No. CAG994003, CI-9685 for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface water becomes necessary, you must file a Report of Waste Discharge with this office and obtain Waste Discharge Requirements (WDRs) prior to discharging any groundwater from the site to surface waters.
