TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT AND WASTE DISCHARGE REQUIREMENT-WEST BASIN MUNICIPAL WATER DISTRICT, EDWARD C. LITTLE WATER RECYCLING FACILITY, 1935 HUGHES WAY, EL SEGUNDO, CALIFORNIA (NPDES NO. CAG994004, CI-9712)

Dear Mr. Deshmukh:

The subject discharges are regulated under Order No. R4-2013-0095, General National Pollutant Discharge Elimination System and Waste Discharge Requirements for Discharges of Groundwater from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, adopted by this Board on June 6, 2013.

We have reviewed your December 18, 2018, letter which requested termination of your coverage under the General NPDES Permit. The letter indicated that the purged groundwater from the monitoring wells at your facility is hauled off site for reuse purposes and that the discharges to the storm drain system at the facility has been terminated. Therefore, the General NPDES permit is no longer needed. Since discharge of groundwater from the wells has ceased, coverage under Board Order R4-2013-0095, General NPDES Permit No. CAG994004, CI-9712 is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface waters or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate waste discharge requirements.
