TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—PARK WATER COMPANY—POTABLE WATER WELL 9D, 2435 EAST GREENLEAF BOULEVARD, COMPTON, CALIFORNIA (NPDES NO. CAG994005, CI—9857)

Dear Ms. Bruno:


In our letter dated April 28, 2012, we informed you that the subject discharge is regulated under Order No. R4-2003-0108, *General NPDES and Waste Discharge Requirements for Groundwater Discharges from Potable Water Supply Wells to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on August 7, 2003.

We have reviewed your letter which requested termination of your coverage under the General NPDES Permit. The letter indicated that construction dewatering project has been completed and the permit is no longer needed. On February 21, 2014, staff inspected the facility and verified that there is no discharge to the storm drain. Since there is no discharge of groundwater from the project site, coverage under Board Order No. R4-2003-00108, General NPDES Permit No. CAG994005, CI-9857 for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface water becomes necessary, you must file a Report of Waste Discharge with this office and obtain Waste Discharge Requirements (WDRs) prior to discharging any groundwater from the site to surface waters.
