TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—LONG BEACH WATER DEPARTMENT—47th STREET SEWER REPLACEMENT PROJECT, ALONG 47TH STREET, BETWEEN RIO AVENUE AND LONG BEACH BOULEVARD, LONG BEACH, CALIFORNIA (NPDES NO. CAG994004, CI—9894)

Dear Mr. Verceles:


In our letter dated December 21, 2012, we informed you that the subject discharge is regulated under Order No. R4-2008-0032, General NPDES and Waste Discharge Requirements for *Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on June 5, 2008.

We have reviewed your July 10, 2013, letter which requested termination of your coverage under the General NPDES Permit. The letter indicated that construction project has been completed and the permit is no longer needed. On December 27, 2013, Board staff inspected the project site and verified that there is no discharge of groundwater from the project site to the storm drain. Since there is no discharge of groundwater from the project site coverage under Board Order No. R4-2008-0032, General NPDES Permit No. CAG994004, CI-9894 for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface water becomes necessary, you must file a Report of Waste Discharge with this office and obtain Waste Discharge Requirements (WDRs) prior to discharging any groundwater from the site to surface waters.
