**TERMINATION OF GENERAL WASTE DISCHARGE REQUIREMENTS FOR CARROLL HALL SHELBY TRUST PROPERTY, 19021 SOUTH FIGUEROA STREET, GARDENA, CALIFORNIA 90248 (FILE NO. 13-036, ORDER NO. R4-2007-0019, SERIES NO. 230, CI-9970, GLOBAL ID WDR100011080)**

Dear Mr. Conway:


On February 3, 2012, Regional Water Quality Control Board (Regional Board) informed you that the injection of cheese whey and emulsified oil into the shallow aquifer as enhanced in situ bioremediation (EISB) for groundwater remediation of volatile organic compounds (VOCs) is regulated under Regional Board Order No. R4-2007-0019, which specifies your Waste Discharge Requirements (WDR).

In a letter dated March 25, 2015, you requested the termination of the WDR coverage under Regional Board Order No. R4-2007-0019 to allow Carroll Hall Shelby Trust (hereinafter Discharger) to enroll under the new Regional Board Order No. R4-2014-0187 on April 22, 2015. The Discharger plans to inject dehalococcoides bacteria in addition to cheese whey and emulsified oil as EISB for groundwater remediation. Dehalococcoides bacteria, cheese whey, and emulsified oil are on the list of materials that can be use for in-situ groundwater remediation purposes under the new Regional Board Order No. R4-2014-0187.

The coverage for the subject facility, under Regional Board Order No. R4-2007-0019, is hereby terminated with the exception of enforcement under the term of the permit.
