TERMINATION OF COVERAGE UNDER GENERAL WASTE DISCHARGE REQUIREMENTS ORDER NO. R4-2007-0019, SERIES NO. 233 – COUNTY OF LOS ANGELES SHERIFF'S DEPARTMENT, LENNOX STATION SITE (C-1 SITE), 4331 WEST LENNOX BOULEVARD, LENNOX CALIFORNIA 90304 (FILE NO. 13-013, ORDER NO. R4-2007-0019, SERIES NO. 233, MONITORING AND REPORTING PROGRAM NO. CI-9975, GLOBAL ID WDR100010107)

Dear Mr. Bolger:

On October 20, 2013, the Los Angeles Regional Water Quality Control Board (Regional Water Board) authorized the injection of materials under the General Waste Discharge Requirements for Groundwater Remediation at Petroleum Hydrocarbon Fuel, Volatile Organic Compound and/or Hexavalent Chromium Impacted Sites, Order No. R4-2007-0019 (General WDR) at the site referenced above. The authorized discharge was implemented under *Appendix E Implementation Plan for the In-situ Chemical Oxidation Pilot Test*, dated July 3, 2013, *Semi-Annual Groundwater Monitoring and Remediation Status Report for First Half 2013 and Updated Workplan for Additional Assessment*, approved by Regional Water Board staff on August 23, 2013.

On April 17, 2019, you requested termination of coverage under the General WDR because insitu chemical oxidation amendment injection using Fenton's Reagent (RegenoOx™ part A and part B) was completed in June 2017 and additional injections are not planned. Therefore, the General WDR is no longer needed. Coverage under General WDR Order No. R4-2007-0019 is hereby terminated except for enforcement purposes.
