ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; LAKE COUNTY DEPARTMENT OF PUBLIC SERVICES, EASTLAKE SANITARY LANDFILL EXPANSION PROJECT (WDID#5A17CR00197A1), LAKE COUNTY

This Order responds to the 30 January 2025 request for an amendment of the Eastlake Sanitary Landfill Expansion Project (Project) Section 401 Water Quality Certification (WDID#5A17CR00197). The original Water Quality Certification (Certification) was issued on 28 January 2025. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Lake County Department of Public Services requested an administrative amendment to remove all temporary impacts, compensatory language required for temporary impacts no longer part of the proposed Project, and a typographical error.

The following items are removed from the Certification and no longer valid:

- Order Table 1 and footnote 1
- Order Section XIV.E.6
- Order Section XIV.J
- Order Section XIV.K.1
- Attachment B – Table 2
- Attachment D - Section B(3)(c)(i) and B(3)(c)(ii)

The Certification is amended as shown below:

- Section J – Now considered “Not Applicable” as a result of removing all temporary impacts and compensatory mitigation required for temporary impacts.

- Section XIII – Fees Received are corrected to Category E – Low Impact Discharges (fee code 87) as a result of removing temporary impacts from total Project impacts.
- In Attachment D, Section B(3)(c)(iii) – Reference to post construction inspection now reads “XIV.C.5.”

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$2,984.00 for the original Certification were received on 3 June 2024. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category E – Low impact Discharges (fee code 87) with the dredge and fill fee calculator.
