**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY
CONDITIONED WATER QUALITY CERTIFICATION; CITY OF SACRAMENTO,
GARCIA BEND BOAT RAMP SILT REMOVAL PROJECT (WDID#5A34CR00591A1),
SACRAMENTO COUNTY**

This Order responds to the 29 April 2024 request for an amendment of the Garcia Bend Boat Ramp Silt Removal Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00591). The original Water Quality Certification (Certification) was issued on 6 June 2014. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

The City of Sacramento is requesting a time extension through 19 May 2025. A time extension was authorized by the United States Army Corps of Engineers on 17 April 2024. The City of Sacramento has provided documentation from the United States Army Corps of Engineers (SPK-2006-00136) authorizing in-water construction activities to continue until 19 May 2025.
