ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; SHALAKO INVESTORS, SHALAKO PROJECT (WDID#5A34CR00619A2), SACRAMENTO COUNTY

This Order responds to the 15 July 2024 request for an amendment of the Shalako Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00619). The original Water Quality Certification (Certification) was issued on 4 January 2019 and amended on 22 August 2022. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Shalako Investors is requesting a time extension through 30 September 2029. The Central Valley Water Board received confirmation from the United States Army Corps of Engineers on 23 July 2024 authorizing in-water construction activities to continue until 30 September 2029.

The Certification is amended to authorize in-water construction activities to continue until 30 September 2029.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$24,941.00 for the original Certification were received on 14 April 2017. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
