ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; L STREET LAND, LP AND BVRP, LP, ELVERTA SPORTS PARK PROJECT (WDID#5A34CR00768A3), SACRAMENTO COUNTY

This Order responds to the 2 October 2024 request for an amendment of the Elverta Sports Park Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00768). The original Water Quality Certification (Certification) was issued on 11 December 2019 and amended on 30 July 2021 (WDID#5A34CR00768A1) and again on 18 March 2022 (5A34CR00768A2). The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

L Street Land, LP and BVRP, LP are requesting a 5-year extension to complete their project. L Street Land, L.P. and BVRP, L.P. have provided documentation from the United States Army Corps of Engineers (SPK-2006-00170) authorizing in-water construction activities to continue for an additional five years from date of issuance. The Certification is amended to reflect an updated expiration date of 10 December 2029.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. An Application Deposit fee of \$1,638.00 for the original Certification was received on 25 April 2019. An additional fee based on the total project impacts of \$22,269.00 was received on 29 July 2019. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), and was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
