ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; SACRAMENTO AREA SEWER DISTRICT (SACSEWER), SACRAMENTO AREA SEWER DISTRICT CREEK CROSSING PROJECT (WDID#5A34CR00861A1), SACRAMENTO COUNTY

This Order responds to the 3 September 2025 request for an amendment of the Sacramento Area Sewer District Creek Crossing Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00861). The original Water Quality Certification (Certification) was issued on 5 January 2023. The requested amendment is hereby approved. The original Certification is therefore amended as described below.

AMENDMENT:

SacSewer is requesting a change in impacts. Originally, the Project consisted of realigning, replacing, and rehabilitating 12 sewer mainline segments throughout Sacramento County at ten distinct Project sites. SacSewer now proposes to realign, replace, and/or rehabilitate a total of 17 sewer mainline segments located within Sacramento County. The pipeline segments, which cross various creeks in Sacramento County, have been identified by SacSewer as part of their Sewer System Management Plan (2021) for improvement due to degrading site conditions such as structural failure and support failure due to erosion, undermining, or exposure.

The additional pipeline segments (asset numbers 42823, 50133, 50520, 76936, and 86730) are located at Myrtle Ave, Oak Lakes Lane, Lindauer Drive, North Parkway, and Marlin Circle in Sacramento County. Four sites are located on or adjacent to Arcade Creek; one site is located on Morrison Creek. The amended proposed project will result in changes to the impact acreage to jurisdictional aquatic features. The new sites include a total of 0.14 acres of temporary impacts to the Riparian aquatic resource and 0.06 acres of permanent impacts to the Stream Channel aquatic resource.
