# ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; B G BUILDER, INC., MORVAI SOUTH SUBDIVISION PROJECT (WDID#5A34CR00901A1), SACRAMENTO COUNTY

This Order responds to the 11 August 2025 request for an amendment of the Morvai South Subdivision Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00901). The original Water Quality Certification (Certification) was issued on 22 November 2024. The requested amendment is hereby approved.
