ORDER AMENDING CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION AND ORDER FOR UNION PACIFIC RAILROAD, UPRR VALLEY SUBDIVISION MILE POSTS 238.79 AND 238.94 BRIDGE REPLACEMENT PROJECT (WDID NO. 5A52CR00248A1), TEHAMA COUNTY

This Order responds to the 29 September 2025 request for an amendment of the Union Pacific Railroad (UPRR) Valley Subdivision Mile Posts 238.79 and 238.94 Bridge Replacement Project Section 401 Water Quality Certification and Order (WDID No. 5A52CR00248). The original Water Quality Certification (Certification) was issued on 20 May 2025. The requested amendment is hereby approved, and the original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

UPRR is requesting an amendment to the Section 401 Water Quality Certification and Order to change the required compensatory mitigation from the purchase of 0.03 acre of Intermittent Drainage Creation credits to 0.03 acre of Constructed Channel credits from Stillwater Plains Mitigation Bank based on current credit availability. The request has been approved and Section XIV.K.2; and Attachment B, Table 5 have been updated, as shown below.

XIV.K Compensatory Mitigation for Permanent impacts:

2. Total Required Compensatory Mitigation

- **a.** The Permittee is required to provide compensatory mitigation for the authorized impact to 0.026 acre of stream channel by purchasing 0.03 acre of Constructed Channel credits from Stillwater Plains Mitigation Bank.
- **b.** The Permittee is required to provide compensatory mitigation for the authorized impact to 0.006 acre of wetlands by purchasing 0.01 acre of Mixed Riparian Woodland Wetland Creation credits from Stillwater Plains Mitigation Bank.
- **c.** Total required Project compensatory mitigation information for permanent
