### **ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; WESTLANDS WATER DISTRICT, LOWER YOLO RESTORATION PROJECT (WDID#5A57CR00185A1), YOLO COUNTY**

This Order responds to the 16 April 2025 request for an amendment of the Lower Yolo Restoration Project (Project) Section 401 Water Quality Certification (WDID#5A57CR00185). The original Water Quality Certification (Certification) was issued on 1 May 2020. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

#### **AMENDMENT:**

Westlands Water District is requesting a time extension through 30 April 2030. Westlands Water District will provide documentation authorizing in-water construction activities to continue once it receives final authorization from the United States Army Corps of Engineers (SPK-2010-01035).

The Certification is amended to authorize in-water construction activities to continue until 30 April 2030.

#### **APPLICATION FEE RECEIVED:**

No fee was required for this amendment. Total fees of \$437.00 for the original Certification were received on 26 August 2019. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category D - Ecological Restoration and Enhancement Projects (fee code 85) with the dredge and fill fee calculator.
