NOTICE OF TERMINATION FOR GENERAL ORDER NO. R5-2008-0149-21 AND RESCISSION OF MONITORING AND REPORTING PROGRAM NO. R5-2007-0828 (REVISED), RAMOS OIL BULK FUEL FACILITY, HIGHWAY 160 AT FIRST STREET, ISLETON, IN SITU REMEDIATION OF PETROLEUM HYDROCARBONS, SACRAMENTO COUNTY

On 16 November 2010, the Executive Officer of the Central Valley Regional Water Quality Control Board issued a Notice of Applicability under General Order No. R5-2008-0149, *In Situ Groundwater Remediation at Sites with Volatile Organic Compounds, Nitrogen Compounds, Perchlorate, Pesticides, Semi-Volatile Compounds, Hexavalent Chromium and/or Petroleum Hydrocarbons.* In the Notice of Applicability the project was assigned site-specific Order No. R5-2008-0149-21.

Injection of ozone, oxygen, and hydrogen peroxide occurred between January 2012 and August 2014. Post remedial monitoring has been conducted and groundwater has not been adversely impacted by the remediation project. Petroleum constituents continue to impact groundwater above Water Quality Objectives after 31 months of remediation system operation. Further remediation, utilizing an alternate treatment method, may be necessary.

Your consultant, Stratus Environmental, Inc., requested termination of General Order coverage for the project on your behalf in a 2 September 2015 letter. Therefore, as of the date of this letter, General Order No. R5-2008-0149-021 is hereby terminated. Additionally, Monitoring and Reporting Program R5-2007-0828 (Revised), which included remediation system monitoring in addition to groundwater monitoring, is hereby rescinded. A new Monitoring and Reporting Program specific to groundwater monitoring will be issued under separate cover. Invoicing for General Order coverage has been modified accordingly.
