**NOTICE OF PUBLIC HEARING**

**TENTATIVE WASTE DISCHARGE REQUIREMENTS  
FOR  
E & J GALLO,  
TURNER ROAD VINTNERS  
SAN JOAQUIN COUNTY**

**TO ALL CONCERNED PARTIES AND AGENCIES**

Tentative Waste Discharge Requirements (WDRs) and a Tentative Monitoring and Reporting Program (MRP) are being issued to E & J Gallo as the owner and operator, also known as the Discharger, for Turner Road Vintners located at 4614 West Turner Road, Lodi, in San Joaquin County. Turner Road Vintners consists of two facilities: Turner Road Vintners West (TRV West) and Turner Road Vintners East (TRV East). The Facilities are separated by approximately two thirds of a mile of agricultural land not owned by the Discharger. The Facilities generate wastewater that is discharged to land from wine making activities. TRV West processes the grapes and bottling occurs at TRV East. Wastewater from both Facilities is commingled and treated by a wastewater treatment system that consists of an Advanced Integrated Pond System (AIPS), a man-made Wetland, and an on-site Storage Lake. The proposed flow limit is 650,000 gallons per day or up to 86 million gallons per year. The WDRs were updated to ensure the discharge is consistent with water quality plans and policies and to incorporate the Salt Control Program.

The designated party for this hearing is E & J Gallo.

**Designated parties**, but not interest parties, will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. Central Valley Water Board staff will prepare the administrative record, and may present evidence, make an oral presentation and cross-examine opposing witnesses.

**Interested persons** may not cross examine witnesses and will not be subject to cross examination. Interested persons may submit evidence (e.g., photographs, eye-witness testimony, monitoring data) if the evidence is submitted in accordance with the deadlines for submitting evidence described below. Interested persons who present evidence may be subject to cross-examination. Interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board by **5:00 p.m. on 29 April 2024**. The request must explain the basis for status as a designated party and in particular how the person is affected by the discharge.

The tentative Waste Discharge Requirements were issued on 28 March 2024. Persons wishing to comment on this item must submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board no later than **5:00 p.m. on 29 April 2024**. Written materials submitted after 5:00 p.m. on the above date will not be accepted and will not be incorporated into the administrative record absent a ruling by the Central Valley Water Board Chair. A party requesting to submit late materials must demonstrate good cause for the late submission, and the Central Valley Water Board Chair must find that the late submission would not prejudice the Central Valley Water Board or any designated party. All designated parties and interested persons may speak at the Central Valley Water Board meeting and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Central Valley Water Board Chair. Both designated parties and interested persons may be asked to respond to clarifying questions from Central Valley Water Board members, counsel staff or others, at the discretion of the Central Valley Water Board.
