**TO ALL CONCERNED PERSONS AND AGENCIES:**

Enclosed are tentative Waste Discharge Requirements (TWDRs) and tentative Monitoring and Reporting Program (MRP) for Vulcan Materials Company and Calmat Co. (Dischargers), Austin Quarry (Facility). The Central Valley Regional Water Quality Control Board (Central Valley Water Board) will be considering adopting the TWDRs at its 18 October 2024 Board Meeting. Any written comments or evidence you may have concerning these items must be submitted to this office by **5:00 p.m. on 6 September 2024**. Absent a showing of good cause and lack of prejudice to other parties, the Board chair may exclude comments and evidence received after this deadline.
