(Discharger), Groundwater Extraction and Treatment Systems ARGET, GET EF, GET HA, GET J, GET KA, GET LA, GET LB, GET AB, White Rock GET, Sailor Bar Park Well, Golden State Water Wells and Low Threat Discharges (Facility). The Discharger must post one (1) copy of the Notice at the nearest city hall or county courthouse, one (1) copy at the post office
