### **Opportunities to Comment**

The Central Valley Water Board will consider oral and written comments on the proposed Order before it votes on whether to adopt the Order.

The Board Chair may refuse to admit any comments or evidence received after the comment period unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party.

**Oral comments** concerning the Order must be presented at the scheduled public meeting. Interested parties are generally allowed up to three minutes each to provide their comments. Certain **designated parties** may provide longer comments and have the right to call and examine witnesses, introduce exhibits, cross-examine opposing witnesses, impeach any witness, and to rebut the evidence against him or her. The parties subject to the proposed Order are designated parties. Any other party may request recognition as a designated party by submitting a written statement of how they are directly affected by the discharge(s) to be regulated and why they would like to be considered a designated party. Such requests must be submitted to Central Valley Water Board no later than 5:00 p.m. on 17 April 2025. Instructions on how to provide oral comments will be included in the Final Agenda for the meeting.

### **Proposed Order**

Waste Discharge Requirements Order R5-2019-0047 (NPDES Permit No. CA0078093) adopted on 7 June 2019 prescribed requirements for the California Department of Corrections and Rehabilitation (Discharger) Deuel Vocational Institution (Facility) in San Joaquin County. Order R5-2019-0047 authorized discharge of up to 0.62 million gallons per day of disinfected, tertiary treated wastewater from the Facility's onsite wastewater treatment plant to Deuel Drain, a water of the United States and tributary of the San Joaquin River via Paradise Cut within the Delta.

Due to changes in the character of the Facility's effluent and based on updated

information, the Facility is eligible for coverage under the NPDES Permit No. CAG995002, General Order R5-2022-0006-03 for Limited Threat Discharges to Surface Water (Limited Threat General Order). A Notice of Applicability (R5-2022-0006-036) for the Limited Threat General Order was issued to the Discharger by the Central Valley Water Board's Executive Officer with an effective date of 1 March 2025. An Order is proposed to rescind the Discharger's NPDES Permit No. CA0078093.
