**NOTICE OF PUBLIC HEARING**  
**concerning**  
**TENTATIVE ORDER**  
**WASTE DISCHARGE REQUIREMENTS**  
**FOR**  
**CALIFORNIA DEPARTMENT OF TRANSPORTATION**  
**MADERA 41 SOUTH EXPRESSWAY: PHASE 1 EA 06-0R040**  
**MADERA COUNTY**

A tentative Waste Discharge Requirements Order (Order) is proposed for the California Department of Transportation (Permittee), Madera 41 South Expressway: Phase 1 EA 06-0R040 (Project) in Madera County. The Project consists of a divided four-lane expressway extension from the current divided four-lane freeway south of Avenue 11 to north of Avenue 15 on State Route 41. Work includes widening shoulders to current standards, replacing and adding culverts, constructing two water detention basins to the east of State Route 41, grading the right-of-way to create v-ditches to direct water flows, constructing sound walls, upgrading metal beam guardrails, and raising the profile as needed. The Project will result in temporary impacts and permanent fill in vernal pools, wetlands, and stream channels. All impacted waters are reportedly deemed by U.S. Army Corps of Engineers to be outside of federal jurisdiction.

The tentative Order provides details of the proposed Project activities, including compensatory mitigation measures planned to compensate for the permanent loss of waters of the state and requiring avoidance and minimization measures to reduce on-site impacts during construction activities. The tentative Order describes technical conditions required to be met throughout the implementation of construction activities to ensure compliance with Sacramento and San Joaquin Rivers Basin Plan objectives and other regulatory requirements.

### **Nature and Purpose of Hearing**

At the hearing, the Central Valley Water Board will hear testimony and oral comments regarding the tentative Order. This proceeding will be a formal adjudicatory proceeding. The **Permittee** is a party to this proceeding and may present evidence, including oral testimony. **Interested persons** include any non-party that is interested in the outcome of the hearing. Excluded material will not be considered by the Board.

The Permittee and any other designated Party will be advised in advance of the hearing of the total amount of time allocated for their presentation, including any witness examination, and closing statement. The Permittee and any other designated Party are invited to contact staff in advance of the hearing to discuss how much time they believe is necessary.

Interested persons may speak at the hearing and are expected to orally summarize their written submittals, if any. Each interested person will have three minutes to present oral comments. Additional time may be provided, upon request, at the discretion of the Board Chair.
