### **Opportunities to Comment**

The Central Valley Water Board will consider oral and written comments on the proposed Order before it votes on whether to adopt the Order.

The Board Chair may refuse to admit any comments or evidence received after the comment period unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party.

**Oral comments** concerning the Order must be presented at the scheduled public meeting. Interested parties are generally allowed up to three minutes each to provide their comments. Certain **designated parties** may provide longer comments and have the right to call and examine witnesses, introduce exhibits, cross-examine opposing witnesses, impeach any witness, and to rebut the evidence against him or her. The party(s) subject to the proposed Order is/are designated parties. Any other party may request recognition as a designated party by submitting a written statement of how they are directly affected by the discharge(s) to be regulated and why they would like to be considered a designated party. Such requests must be submitted to Central Valley Water Board no later than 5:00 p.m. on **23 June 2025**. Instructions on how to provide oral comments will be included in the Final Agenda for the meeting.

### **Proposed Order**

If adopted, the proposed Order will rescind WRRs Order No. 5-01-082, which prescribes an agreement between Sentinel Butte Mutual Water Company (User) and the City of Woodlake (Producer) to reclaim undisinfected secondary treated wastewater from the Producer's wastewater treatment facility (WWTF) on 35 acres of pastureland (reclamation area) owned by the User. The WWTF is regulated separately by Waste Discharge Requirements (WDRs) Order R5-2009-0103. On 20 March 2025, The Central Valley Water Board received a letter from the Producer stating that recycled water is no longer sent to the User's reclamation area. On 6 May 2025, the Central Valley Water Board received a letter from the User signed by its President, Todd Conselasco, confirming that the reclamation area will no longer be receiving recycled water from the Producer. In addition, the Producer's March 2025 letter included a revised water balance, signed and stamped by Steven Beck (RCE 43799), that demonstrates that sending recycled water to the reclamation area is not necessary for the WWTF to manage permitted flows.
