Enclosed is a tentative Time Schedule Order for the Stallion Springs Community Services District (Discharger), Wastewater Treatment Facility (Facility). In accordance with the enclosed Notice of Public Hearing (Notice), written comments and evidence concerning the proposed Order must be submitted to this office no later than 5:00 p.m. on **14 July 2025**. Written material submitted after 5:00 p.m. on **14 July 2025** will not be accepted and incorporated into the administrative record absent a ruling by the Board Chair.

A Public Hearing has been scheduled for the Central Valley Regional Water Quality Control Board (Central Valley Water Board) to consider adoption of the proposed Order at its **21-22 August 2025** Board Meeting. See the enclosed Notice for additional information about the Public Hearing. The Discharger must post one (1) copy of the Notice at the Discharger's offices and one (1) copy at the post office nearest to the Facility (if allowed). Please post the Notice as soon as possible and provide proof of posting, using the enclosed form, by **27 June 2025**.
