**PROPOSED SITE CLEANUP CASE CLOSURE PUBLIC COMMENT PERIOD**  
4 June 2025 - 4 July 2025

#### **PUBLIC NOTICE:**

The Central Valley Regional Water Quality Control Board (Central Valley Water Board) is providing notice of a proposed No Further Action determination near Vasco Road on the Jackson Family Ranch and the Byron Vernal Pools Regional Preserve in Contra Costa County (Site). A map showing the location is included as Figure 1.

#### **CASE SUMMARY:**

The Site is in a rural area that is currently used as open pastureland and as a wildlife preserve near Vasco Road in Byron. A Phillips 66 (P66) crude oil pipeline (Line 200) runs northwest to southeast along approximately five acres through both the East Bay Regional Park District and Jackson Family Ranch properties. On 22 August 2011, P66 detected an unexpected pressure drop and remotely shutdown the pipeline. After identifying the damaged portion of pipeline, P66 conducted repair of the pipeline; excavated the impacted soil and vegetation; and removed any liquid hydrocarbons.

From 2012 to 2023, P66 conducted three Site assessments to monitor groundwater and soil concentrations of total petroleum hydrocarbons and associated constituents. In 2023, P66 submitted a request for no further action at the Site. The remaining low levels in groundwater do not threaten drinking water and no future buildings can be constructed in the pipeline easement right of way. Therefore, Central Valley Water Board staff find there is merit to the request.

The Central Valley Water Board is providing the public with an opportunity to comment on the request for No Further Action.
