# NOTICE OF OPPORTUNITY TO COMMENT AND STAFF WORKSHOP

2024 Triennial Review Draft Workplan for the Water Quality Control Plans for the Sacramento River and San Joaquin River Basins and the Tulare Lake Basin (Basin Plans)

NOTICE IS HEREBY GIVEN THAT the Central Valley Regional Water Quality Control Board (Central Valley Water Board or Board) is accepting written comments regarding the 2024 Triennial Review Draft Workplan (Draft Workplan) through 29 July 2024. Furthermore, Central Valley Water Board staff will hold a staff workshop on 08 July 2024 to provide participants with an opportunity to discuss the Central Valley Water Board's 2024 Triennial Review Draft Workplan. The Central Valley Water Board will conduct a public hearing to consider adoption of the Triennial Review Workplan at a later date, which will be separately noticed.

This Notice provides (1) a brief background on the Triennial Review process, (2) information on how to review and comment on the Draft Workplan, and (3) information on how to participate in the staff-led workshop on the Draft Workplan.

#### **Background on the Triennial Review Process:**

To meet requirements of section 303(c) of the federal Clean Water Act and Water Code section 13240, the Central Valley Water Board reviews its Basin Plans every three years, which is known as the Triennial Review. The Triennial Review consists of solicitation of comments on water quality issues in the Central Valley that may need to be addressed through Basin Plan amendments and the subsequent preparation of a prioritized workplan for both Basin Plans.

The Triennial Review process does not itself amend the Basin Plans nor does it include consideration of waste discharge requirements, waivers of waste discharge requirements, National Pollutant Discharge Elimination System permits, or other permitting matters.

The Board's Triennial Review solicitation process includes providing an opportunity for interested persons to provide written comments to the Board. After the Board receives public input, the Board develops and adopts a prioritized workplan that is used to direct basin planning efforts over the next three years. Implementation of the workplan depends upon the Board's program priorities, resources, and other mandates and commitments.

The solicitation period for the 2024 Triennial Review was 05 January 2024 to 21 February 2024. Based on comments received during the solicitation period, Board staff prepared a Draft Workplan that includes both Basin Plans. The Draft Workplan includes a review of Basin Plan amendments since the 2021 Triennial Review, an overview of proposed projects, available Board resources, and project prioritization and ranking.

### **Draft Workplan Written Comment Period:**

Written comments on the Draft Workplan will be accepted during the 30-day public comment period at the Rancho Cordova office and through email. Staff will compile comments and use them to inform the development of the 2024 Triennial Review Proposed Workplan that will be presented to the Board for adoption in a future meeting.
