# STAFF REPORT

#### ITEM:

**SUBJECT:** Pulte Home Company, LLC., Avelina Residential Development Line A-H Project, City of Perris, Riverside County, R8-2024-0053

### DISCUSSION:

Based on the scope of the federal regulatory definition of waters of the United States (WOTUS), not all discharge activities are considered discharges of dredged or fill materials to WOTUS. Pursuant to the Porter-Cologne Water Quality Control Act (Wat. Code, § 13000 et seq.), the Tentative Order prescribes Waste Discharge Requirements (WDRs) for dredged and fill materials to surface waters that are not considered Waters of the United States (WOTUS) and are subject to the federal Clean Water Act. (See Wat. Code, § 13263, subd. (a).) Non-WOTUS surface waters are referred to as Waters of the State (WOTS).

The attached Order prescribes WDRs for the Avelina Residential Development Line A-H Project. The Order regulates the discharge of fill material to waters of the state.

Line A-H was originally constructed as an earthen sided and concrete bottom channel in upland areas serving as a storm water drainage facility that runs along the south side of Avelina Residential Development. The reconstruction of the Line A-H as an expanded concrete trapezoidal channel was previously authorized by the Santa Ana Water Board on June 16, 2017, under Order R8-2017-0028. However, the reconstruction of Line A-H has not yet commenced. This Order formally rescinds and replaces Order R8-2017-0028 as the operative WDRs for the Project.

The Project activities consist of removing and replacing Line A-H to meet its new design specifications. The Project will remove the existing sections of concrete and install a 6-inch-thick reinforced concrete trapezoidal channel with 1.5:1 side slopes and a bottom width of 15 feet. The total width of the Line A-H channel will be 42.8 feet. Once complete, Line A-H Channel will be an approximately 2-acre (2,323 linear feet) concrete trapezoidal channel. The Project includes sediment removal in the south end of Evans Channel and placement of a concrete connection structure to Line A-H.

Within the existing Evans Channel Basin, a 15-foot-wide concrete access ramp, a 15-foot-wide access road, and a concrete transition structure on the southern end of the basin to transition from the 1.5:1 to 3:1 slopes will be constructed. In the channel

transition area from curved to linear alignment, the south bank will be protected with light-class rip-rap slope protection. The Project replaces any temporary outflow connection to the Perris Valley Storm Drain Channel (PVSD) with a permanent outflow structure. It also removes sediments within and adjacent to the jurisdictional limits of PVSD associated with reconstruction of Line A-H. In addition, a 79.5-foot-long by 31-foot-wide bridge will also be installed over the Line A-H channel.

The ephemeral waters of the state that are present on the Project site include Line A-H Channel, Evans Channel and the PVSD Channel. Evans Channel is east of Line A-H and PVSD is located west of Line A-H. Implementation of the Project would result in the permanent degradation of 0.26 acres of ephemeral waters of the state. The permanent impacts to waters of the state are a result of removing and replacing Line A-H with an expanded concrete-lined channel. Additional impacts include sediment removal and placement of a concrete connection structure between Evans Channel and Line A-H as well as replacing outflow connection to PVSD Channel.

Compensatory mitigation for permanent impacts to waters of the state associated with degradation of water quality has been offset through construction of the earthen Evans Channel, and Line A-H. Evans Channel and Line A-H were constructed by the Permittee in the upland areas to serve as flood control facilities. Additionally, the Permittee widened a portion of the PVSD. No additional compensatory mitigation is required as Project activities will not result in physical loss of the waters of the state.

The Project activities would implement Best Management Practices (BMPs) to control and prevent discharges, such as sediment from erosion of soil surfaces and other pollutants that could impact surface waters. The Discharger proposes that BMPs would be implemented as part of the stormwater pollution prevention measures in accordance with appropriate stormwater permit requirements.

Santa Ana Water Board staff are relying on the Mitigated Negative Declaration (MND) for compliance with CEQA and staff have determined that no further environmental review is required for the Project under the CEQA Guidelines.

# WASTE DISCHARGE REQUIREMENTS FOR DISCHARGES OF DREDGED OR FILL MATERIALS TO WATERS OF THE STATE AVELINA RESIDENTIAL DEVELOPMENT LINE A-H PROJECT RIVERSIDE COUNTY

# **FINDINGS**

The Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) hereby finds as follows:

- 1. This Order prescribes Waste Discharge Requirements (WDRs) for the Avelina Residential Development Line A-H Project (Project) of Pulte Home Company, LLC (Discharger).
- 2. Receiving waters and groundwater potentially impacted by this Project are protected in accordance with the operative Water Quality Control Plan for the Santa Ana River Basin (Basin Plan) and all other pertinent plans and policies. The Basin Plan includes water quality standards, which consist of existing and potential beneficial uses of waters of the state, water quality objectives to protect those uses, and the state and federal antidegradation policies.
- 3. The Santa Ana Water Board has the authority to regulate the discharge of dredged and fill materials by prescribing WDRs pursuant to California Water Code section 13263. The Santa Ana Water Board has determined that WDRs are necessary to adequately address the Project's potential impacts on the beneficial uses of waters of the state.
- 4. This Order regulates the discharge of fill material to waters of the state, in accordance with the State Water Resources Control Board's (State Water Board) State Policy for Water Quality Control: State Wetland Definition and Procedures for Discharges of Dredged or Fill Material to Waters of the State (Dredge and Fill Procedures), as revised on April 6, 2021.
- 5. On October 13, 2023, L&L Environmental Inc., on behalf of the Discharger, submitted an Application for Discharges of Dredged or Fill Material to Waters of the State (Application) for the Project, which was assigned Santa Ana Water Board WDID No. 332023-30.
- 6. The Application was deemed complete on May 20, 2024.

7. On March 6, 2024, the Army Corps of Engineers issued an Approved Jurisdictional Determination, which determined that waters of the United States were not present within the Project boundaries.

#### **Project Description and Discharge Characteristics**

- 8. The Project is located within the City of Perris in Riverside County and encompasses approximately five (5) acres (Latitude 33°48' 36.66" N, Longitude 117°12' 09.79" W). The Project site is associated with Assessor Parcel Number 320-542-019, 320-561-033, and a portion of APN 320-561-033 and 320-430-008. The Project site is west of Evans Road, south of Moraga Avenue, and is northwest of the intersection of Sunset Avenue and Evans Road. Maps showing the Project location are found in Attachment A of this Order.
- 9. Line A-H was originally constructed as an earthen sided and concrete bottom channel in upland areas during August 2006 to June 2009. Line A-H serves as a storm water drainage facility that runs along the south side of Avelina Residential Development and discharges to the Perris Valley Storm Drain Channel (PVSD).
- 10. The Santa Ana Water Board previously authorized the reconstruction of Line A-H to a widened concrete trapezoidal channel under Order R8-2017-0028 on June 16, 2017. However, the reconstruction of Line A-H has not yet commenced. This Order formally rescinds and replaces Order R8-2017-0028 as the operative WDRs for the Project.
- 11. The Project activities consist of reconstructing Line A-H to meet its new design specifications. The Project will remove the existing sections of concrete and install a 6-inch-thick reinforced concrete trapezoidal channel with 1.5:1 side slopes and a bottom width of 15 feet. The total width of the Line A-H channel will be 42.8 feet. The embankments of the widened channel will be compacted, and a 3-inch layer of 1-inch coarse aggregate will be placed on the embankments. Line A-H runs along the south side of Avelina Residential Development for 1,963 lineal feet. It also includes a hydraulic junction basin which runs parallel to Evans Road for 360 lineal feet. Once complete, Line A-H Channel will be an approximately 2-acre (2,323 linear feet) concrete trapezoidal channel.
- 12. The Project includes sediment removal in the south end of Evans Channel and placement of a concrete connection structure to Line A-H. Within the existing Evans Channel Basin, a 15-foot-wide concrete access ramp, a 15-foot-wide access road, and a concrete transition structure on the southern end of the basin to transition from the 1.5:1 to 3:1 slopes will be constructed.
- 13. Line A-H has two reach sections with curved alignments including a 180-foot radius curve and a 60-foot radius curve. In the channel transition area from curved to linear alignment, the south bank will be protected with light-class rip-

rap slope protection. The same will occur along the channel bottom adjacent to the slope to protect against flows from Line A-H as they enter PVSD as designed to prevent erosion and slow flow velocities as the two channels confluence. In total, approximately ¼ ton of rip-rap will be placed as part of the junction structure with the PVSD.

- 14. The Project will replace any temporary outflow connection to the PVSD with a permanent outflow structure.
- 15. Additional Project activities include sediment removal within and adjacent to the jurisdictional limits of the PVSD associated with reconstruction of Line A-H.
- 16. In addition, a 79.5-foot-long by 31-foot-wide bridge will also be installed over the Line A-H channel.
- 17. The ephemeral waters of the state that are present on the Project site include Line A-H Channel, Evans Channel and the PVSD Channel. Evans Channel is east of Line A-H and PVSD is located west of Line A-H.
- 18. Implementation of the Project would result in the permanent degradation of 0.26 acres of ephemeral waters of the state. The permanent impacts to waters of the state are a result of reconstruction of Line A-H with an expanded concrete-lined channel. Additional impacts include sediment removal and placement of a concrete connection structure between Evans Channel and Line A-H as well as replacing outflow connection to PVSD.
- 19. The Project will impact Line A-H, and PVSD, ephemeral drainages tributaries to San Jacinto River. San Jacinto River, Reach 4, has the following designated beneficial uses (existing or potential): Rare, Threatened, or Endangered Species.
- 20. Compensatory mitigation for the authorized impacts to waters of the state for the reconstruction (including concrete lining and widening) of Line A-H is satisfied through construction of the earthen Evans Channel, and Line A-H. Evans Channel and Line A-H were constructed by the Permittee in the upland areas associated with the construction of the Avellina Residential Development Project to serve as flood control facilities. Additionally, the Permittee widened a portion of the PVSD. The completion of Line A-H will not result in a physical loss of waters of the state. Therefore, no compensatory mitigation is required for the Project.

### **Regulatory Considerations**

21. This Order is adopted pursuant to Water Code section 13263, subdivision (a), which provides that the Santa Ana Water Board may, after any necessary hearing, prescribe requirements (WDRs) as to the nature of any proposed discharge with relation to the conditions existing in the disposal area or receiving

waters upon, or into which, the discharge is made or proposed. The WDRs are required to implement any relevant water quality control plans that have been adopted and take into consideration the beneficial uses to be protected, the water quality objectives reasonably required for that purpose, other waste discharges, the need to prevent nuisance, and the provisions of Water Code section 13241.

- 22. This Order is also adopted pursuant to Water Code section 13267, subdivision (b)(1) which authorizes the Santa Ana Water Board to require technical and monitoring program reports, submitted under penalty of perjury, from persons discharging or proposing to discharge waste within the Santa Ana Region, in connection with the issuance of WDRs. This Order incorporates requirements for water quality monitoring and Project reporting, which are necessary to ensure that the discharge of dredged and fill material complies with WDRs and is protective of the water quality. In accordance with Water Code section 13267, the burden, including costs, of generating these reports bears a reasonable relationship to the need for the report and the benefits to be obtained from them.
- 23. The Santa Ana Water Board has considered the federal and state antidegradation policies (State Water Board Resolution 68-16; 40 C.F.R § 131.12) and finds that the discharge permitted under this Order is consistent with those policies. Filling wetlands, riparian areas, headwaters, and other waters causes partial or complete loss of the beneficial uses provided by those waters. This Order requires that impacts to waters of the state be mitigated through avoidance and minimization to the maximum extent practicable and that unavoidable loss of beneficial uses is offset with compensatory mitigation, including the restoration (reestablishment or rehabilitation), establishment (creation), enhancement, and/or preservation of other waters of the state. The mitigation requirements in this Order comply with the State Water Board's Dredge and Fill Procedures.
- 24. This Order is subject to modification or revocation upon administrative or judicial review, including review and amendment pursuant to Water Code section 13330 and California Code of Regulations, title 23, section 2050 et seq. Additionally, the Santa Ana Water Board reserves the right to suspend, cancel, or modify and reissue this Order, after providing notice to the Discharger, if the Santa Ana Water Board determines that the Project fails to comply with any of the conditions of this Order; or when necessary to implement any new or revised water quality standards and implementation plans adopted or approved pursuant to the Porter-Cologne Water Quality Control Act (Wat. Code, § 13000 et seq.)
- 25. The provisions of this Order are severable and, if any provision of this Order or the application of any provisions of this Order to any circumstance is held invalid,

the application of such provision to other circumstances and the remainder of this Order shall not be affected thereby.

- 26. A request for modification, revocation and re-issuance, or termination of this Order or a notification of planned changes or anticipated noncompliance does not stay any requirements of this Order.
- 27. The requirements prescribed herein do not authorize the commission of any act causing injury to the property of another, nor protect the Discharger from liabilities under federal, state, or local laws, nor guarantee the Discharger a capacity right in the receiving waters.
- 28. This Order does not convey any property rights of any sort, or any exclusive privilege. The ability to discharge waste is a privilege, not a right; nothing in this Order shall create a vested right to continue any discharges authorized herein, which are subject to rescission or modification. (Wat. Code, § 13263, subd. (g).)

### **CEQA and Public Participation**

- 29. On April 22, 1991, the Riverside County Flood Control, as the lead agency under the California Environmental Protection Act (CEQA; Public Resources Code, § 21000 et seq.) adopted a Negative Declaration (ND) for the revised Master Drainage Plan for the Perris Valley Area which consists of construction of a system of flood control channels including Line A-H. On July 8, 2003, the City of Perris, as the lead agency under the CEQA conducted an Initial Study and adopted a Mitigated Negative Declaration (MND) for the General Plan Amendment, Zone Change and Tentative Tract Map No. 30850. The construction of Line A-H within the Tentative Tract Map No. 30850 (Avelina Residential Development) site was a condition of the City of Perris CEQA approval. The lead agency filed a Notice of Determination with Riverside County Clerk on July 9, 2003.
- 30. The Santa Ana Water Board is a responsible agency under CEQA for the purposes of issuing this Order. As a responsible agency, the Santa Ana Water Board is "responsible for considering only the effects of those activities involved in a project which it is required by law to carry out or approve." (Public Resources Code, § 21002.1, subd. (d).) In approving this Order, the Santa Ana Water Board has considered the MND adopted by the City of Perris and subsequent information provided by the Discharger. More specifically, the Santa Ana Water Board considered those sections of the MND pertaining to impacts to water quality. The Santa Ana Water Board finds that compliance with the mitigation measures of the MND and conditions in this Order will reduce potentially adverse impacts to water quality to a less than significant level and protect beneficial uses of receiving waters.

- 31. For the purposes of Water Code section 189.7, subdivision (a)(1), the proposed waste discharges are not anticipated to result in disproportionate water quality impacts to any disadvantaged communities or tribal communities.
- 32. This Order does not include a time schedule for achieving a water quality objective or any similar provision involving delayed compliance with an objective. Accordingly, no findings are required under Water section 13149.2, subdivision (d).
- 33. The Santa Ana Water Board, in a public meeting, heard and considered all comments pertaining to the WDRs for the discharge.

### REQUIREMENTS

**IT IS HEREBY ORDERED** that, pursuant to Water Code sections 13263 and 13267, Order R8-2017-0028 is hereby rescinded (except for enforcement purposes), and that the Discharger shall comply with the following requirements.

#### A. Discharge Specifications

- 1. No activities associated with the Project shall cause or threaten to cause a condition of nuisance, contamination or pollution as defined in Water Code section 13050.
- 2. The groundwater in the vicinity of the Project shall not be degraded resulting from the Project activities or placement of fill materials for the Project.
- 3. The Discharger shall, as applicable, obtain coverage under and comply with the *NPDES General Permit for Storm Water Discharges Associated with Construction and Land Disturbance Activities*, State Water Board Order WQ 2022-0057-DWQ, NPDES No. CAS000002) (Construction General Permit) and any subsequent amendments thereto. If the Project construction activities do not require coverage under the Construction General Permit, the Discharger shall develop and implement a runoff management plan or equivalent construction best management practices (BMP) plan, to prevent the discharge of sediment and other pollutants during construction activities.
- 4. The Discharger shall comply with the local regulations associated with the Santa Ana Water Board's Municipal Stormwater Permit issued to Riverside County and co-permittees under NPDES No. CAS618033 and WDRs Order R8-2010-0033, and subsequent iterations thereof.

- 5. If construction dewatering discharges, including temporary stream diversions, are necessary to carry out the Project, the Discharger shall enroll and comply with the Santa Ana Water Board Order R8-2020-0006, *General Waste Discharge Requirements for Discharges to Surface Waters that Pose an Insignificant (De Minimis) Threat to Water Quality.*
- 6. Discharges of fill materials shall be limited to the placement of native fill and "inert waste", as defined in California Code of Regulations, title 27, section 20230. Fill material other than native soil shall not be discharged as part of the project.
- 7. Construction and post-construction best management practices (BMPs) shall be implemented.

### B. Discharge Prohibitions

- 1. Permanent impacts to waters of the state from the Project shall not exceed quantities identified in Finding No. 19.
- 2. Expect as expressly authorized in another WDRs order, waste shall not be discharged in a manner or location other than as described in Findings 11-20, and the Application referenced in Findings 5-6.
- 3. Except for authorized fill material discharges to waters of the state, the direct discharge of wastes, including rubbish, refuse, bark, sawdust, or any other solid or liquid wastes, into water channels, surface waters, or any place where they would contact or be eventually transported to surface waters, including flood plains, is prohibited.
- 4. The discharge of oil or other floating materials from any activity in quantities sufficient to cause deleterious bottom deposits, turbidity, or discoloration in surface waters is prohibited.
- 5. The discharge of silt, sand, clay, or other earthen materials from any activity in quantities sufficient to cause deleterious bottom deposits, turbidity, or discoloration in surface waters is prohibited.
- 6. Discharges to surface waters of wastes or pollutants that are not authorized by this Order or regulated by a separate permit are prohibited.
- 7. During the grading and filling operation, there shall be no onsite fueling, lubrication, changing of oil or other equipment fluids and their filters, or any other maintenance or storage of construction equipment within or next to drainage areas or other surface runoff conveyances.

### C. Provisions

- 1. The Discharger shall maintain a copy of this Order at the Project site so that it is always available to site operating personnel. Key operating personnel shall be familiar with the Order's content.
- 2. The Discharger shall take all reasonable steps to minimize or prevent any discharge that has a reasonable likelihood of adversely affecting human health and the environment.
- 3. This Order is not transferable to any person without written approval by the Santa Ana Water Board's Executive Officer. Prior to any change in ownership, the Discharger shall notify the Santa Ana Water Board's Executive Officer in writing at least 30 days in advance. The notice shall include a written transfer agreement between the existing owner and the new owner. At a minimum, the transfer agreement shall contain a specific date for transfer of responsibility for compliance with this Order and an acknowledgment that the new owner or operator is liable for compliance with this Order from the date of transfer. The Santa Ana Water Board may require modification or revocation and reissuance of this Order to change the name of the Discharger and incorporate other requirements as may be necessary under the Water Code.
- 4. The reporting period is from January 1st to December 31st. The Discharger shall submit an annual report each year no later than January 31st for the previous reporting period if the Order effective date is at least 90 days within the reporting period. Annual reporting shall continue until a *Notice of Project Complete Letter* is issued to the Discharger. The contents of the annual report shall include a construction summary, Project status and schedule (including ground disturbance, site clearing and grubbing, and site construction), and the implementation status of BMPs during the active discharge period. If the Project has not started, the Discharger shall provide an estimated start date and reasons for any expected delays.
- 5. The Discharger shall submit a *Commencement of Construction Report* at least seven days prior to start of initial groundbreaking activities.
- 6. The Discharger shall submit a *Request for Notice of Completion of Discharges Letter* following completion of active Project construction activities, including any required restoration and Discharger-responsible mitigation. This request shall be submitted to Santa Ana Water Board staff within 30 days following the completion of all Project construction activities. Upon acceptance of the request, Santa Ana Water Board staff will issue to the Discharger a *Notice of Completion of Discharges Letter*,

which will end the active discharge period and, if appropriate, associated annual fees.

- 7. The Discharger shall submit a *Request for Notice of Project Complete Letter* when construction and any required post-construction monitoring is complete and no further Project activities will occur. This request shall be submitted to Santa Ana Water Board staff within 30 days following the completion of all Project activities. Upon approval of the request, Santa Ana Water Board staff will issue to the Discharger a *Notice of Project Complete Letter* and prepare a draft order terminating this Order for approval by the Santa Ana Water Board. The *Notice of Project Complete Letter* will end the post-discharge monitoring period, and either the expiration or Board approval of the termination of this Order will end the associated annual fees.
- 8. The Discharger shall retain records of all monitoring information, including all calibration and maintenance records, copies of all reports required by this Order, and records of all data used to complete the application for this Order. Records shall be maintained for a minimum of five years from the date of the sample, measurement, report, or application. Records may be maintained electronically. This period may be extended during for any unresolved enforcement action or litigation regarding this discharge or when requested by the Santa Ana Water Board.
- 9. The Discharger shall report any noncompliance that may endanger human health or the environment. Information shall be provided orally to the Santa Ana Water Board office and the Office of Emergency Services within twenty-four (24) hours of when the Discharger becomes aware of the incident. If noncompliance occurs outside of business hours, the Discharger shall leave a message on the Santa Ana Water Board's office voicemail. A written report shall also be provided within five business days of the time when the Discharger becomes aware of the incident. The written report shall contain a description of the noncompliance and its cause, the period of noncompliance, the anticipated time to achieve full compliance, and the steps taken or planned to reduce, eliminate, and prevent recurrence of the noncompliance. All other forms of noncompliance shall be reported with the Discharger's next scheduled Monitoring Report, or earlier if requested by the Executive Officer.
- 10. Before initiating a new discharge or making a material change in the character, location, or volume of an existing discharge, the Discharger shall report all pertinent information in writing to the Santa Ana Water Board, and if required by the Santa Ana Water Board, obtain revised requirements before any modifications are implemented.

- 11. The Discharger shall allow the Santa Ana Water Board, or an authorized representative, upon presentation of credentials and other documents as may be required by law to:
  - a. Enter premises where a regulated facility or activity is located or conducted, or where records are kept under the requirements of this Order;
  - b. Access and copy any records that are kept under the requirements of this Order;
  - c. Inspect any facility, equipment (including monitoring and control equipment), practices, or operations regulated or required under this Order; and
  - d. Photograph, sample, or monitor for the purpose of assuring compliance with this Order or as otherwise authorized by the Water Code.
- 12. This Order becomes effective on the date of adoption by the Santa Ana Water Board.
- 13. This Order will remain valid for five years from the date of its adoption. The Discharger shall file a new dredge and fill application in accordance with California Code of Regulations, title 23, division 3, chapter 9 no later than 180 days in advance of this expiration date. The application, with filing fee, will be discussed between the Discharger and Santa Ana Water Board staff regarding any need for additional information and changes in fees prior to the issuance of new WDRs.

### ENFORCEMENT



Water Code sections 13300 and 13308, or referral to the California Attorney General for recovery of judicial civil liability.

### ADMINISTRATIVE REVIEW

Any person aggrieved by this Santa Ana Water Board action may petition the State Water Board for review in accordance with Water Code section 13320 and California Code of Regulations, title 23, section 2050 et seq. To be timely, the petition must be received by the State Water Board by 5:00 pm on the 30th day after the date of this Order; if the 30th day falls on a Saturday, Sunday or state holiday, the petition must be received by the State Water Board by 5:00 pm on the next business day. - 2) <u>Request for Notice of Completion of Discharges Letter</u>: This request by the Discharger to the Santa Ana Water Board staff pertains to projects that have post construction monitoring requirements (e.g., if site restoration were required to be monitored for five (5) years following construction). Santa Ana Water Board staff will review the request and send a *Completion of Discharges Letter* to the Discharger upon approval. This letter will initiate the post-discharge monitoring period and a change in fees from the annual active discharge fee to the annual post-discharge monitoring fee.
- 3) <u>Request for Notice of Project Complete Letter:</u> This request by the Discharger to the Santa Ana Water Board staff pertains to projects that either have completed post-construction monitoring and achieved performance standards, or have no post-construction monitoring requirements and no further Project activities are planned. Santa Ana Water Board staff will review the request and send a *Project Complete Letter* to the Discharger upon approval. Termination of annual invoicing of fees will correspond with the expiration or termination by Board action of this Order.
