AVELINA RESIDENTIAL DEVELOPMENT LINE A-H PROJECT RIVERSIDE COUNTY

TENTATIVE ORDER R8-2024-0053

NOTICE IS HEREBY GIVEN that the Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) is releasing for public review and comment tentative Order R8-2024-0053 (Tentative Order) to Pulte Home Company, LLC. (Discharger) for the Avelina Residential Development Line A-H Project (Project).

The Project encompasses the reconstruction of the stormwater drainage facility (Line A-H) south of the Avelina Residential Development as well as the outflow connection to the Perris Valley Storm Drain Channel (PVSD) and a concrete connection structure between the south end of Evans Channel and Line A-H. The construction of the Project will result in the permanent degradation of 0.26 acre of ephemeral waters of the state. The permanent impacts are a result of reconstruction of Line A-H as a widened concrete-lined channel.

The Santa Ana Water Board intends to consider adopting the Tentative Order during a public hearing at a regularly scheduled Santa Ana Water Board meeting as follows:
