NOTICE IS HEREBY GIVEN THAT the California Regional Water Quality Control Board, Santa Ana Region (Santa Ana Water Board) is accepting comments on the Draft Cleanup and Abatement and Water Code Section 13267 Investigative Order (Order) for Ramiro Paez Hernandez (Ramiro Paez) and Emily Abigail Sanchez, Raul Ayala Silva (Raul Ayala) and Felipe de Jesus Rosales Herrera, and Rene and Gaudencia Cardona, (collectively referred to as the Dischargers), inclusive Riverside County Assessor Parcel Numbers (APNs) 390-290-010, 390-290-011, and 390-290-012, respectively.

Subject Site: Riverside County APNs 390-290-010, 390-290-011, and 390-290-012 in Lake Elsinore, California.

The Draft Order requires the Dischargers to clean up cannabis cultivation related waste and sediment that is discharging or threatening to discharge to tributaries of Temescal Creek, pursuant to Water Code section 13304, and to submit technical or monitoring reports, pursuant to Water Code section 13267. The Draft Order names Ramiro Paez and Emily Abigail Sanchez, Raul Ayala and Felipe de Jesus Rosales Herrera, and Rene and Gaudencia Cardona as the responsible parties for discharges or threatened discharges originating from the Subject Site.
