NOTICE OF WRITTEN COMMENT PERIOD FOR SETTLEMENT OFFER NO. R9-2025-0159 RELATED TO VIOLATIONS OF ORDER R9-2015-0013, NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM NO. CAG919003 FOR DANA POINT HARBOR PARTNERS, LLC, DANA POINT HARBOR REVITALIZATION PROJECT, DANA POINT, CA 92629, DISCHARGE TO THE DANA POINT HARBOR

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing, for public review and comment, Settlement Offer No. R9-2025-0159 Related to Violations of Order R9-2015-0013, National Pollutant Discharge Elimination System No. CAG919003 for Dana Point Harbor Partners, LLC, Dana Point Harbor Revitalization Project, Dana Point, CA 92629, Discharge to the Dana Point Harbor (Settlement Offer). The Settlement Offer is an agreement between Dana Point Harbor Partners, LLC (Discharger) and the San Diego Water Board to address alleged violations of Order R9-2015-0013, National Pollutant Discharge Elimination System (NPDES) Permit CAG919003, General Waste Discharge Requirements for Groundwater Extraction Discharges to Surface Waters Within the San Diego Region (General Order). To resolve the alleged violations without formal administrative proceedings, the Discharger has agreed to pay the mandatory minimum penalties related to alleged violations in the amount of \$27,000.
