The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board), is releasing Tentative Order No. R9-2026-0003, *Waste Discharge Requirements for Closure and Post-Closure Maintenance and Monitoring for Ramona Landfill, Inc., a Subsidiary of Republic Services, Ramona Landfill, San Diego County, California* (Tentative Order), for public review and comment.

Submission of Written Comments

Notice is hereby given that the San Diego Water Board will accept written comments regarding the Tentative Order in accordance with this notice.

The written comment period provides an opportunity for interested persons to comment on the Tentative Order. All written comments regarding the Tentative Order must be received no later than **5:00 p.m. on Monday February 16, 2026**, to be considered by the San Diego Water Board. Written comments sent by mail must be addressed to California Regional Water Quality Control Board – San Diego Region, 2375 Northside Drive, Suite 100, San Diego, California 92108-2700, and ATTN: Erin Schmitt. Comments can also be submitted by email to sandiego@waterboards.ca.gov. The subject line of all written comments must include “Comment – Tentative Order No. R9-2026-0003.”

The early submission of written comments on the Tentative Order is encouraged. Written comments received by **5:00 p.m. on Monday February 16, 2026**, will be provided to the San Diego Water Board members for their review in advance of the public hearing to consider the adoption of the Tentative Order. The San Diego Water Board will prepare written responses to significant comments that are timely received. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Monday February 16, 2026**, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

Public Hearing for Consideration of the Tentative Order

The San Diego Water Board will publish a *Meeting Notice and Agenda* in advance of the public hearing for the Tentative Order. The *Meeting Notice and Agenda* will indicate the meeting date, time, location, and may provide other specific information concerning this hearing.
