
Enclosed is a copy of Tentative Addendum No. 2 to Order No. R9-2003-0155, NPDES Permit No. CA0109347, and a fact sheet in support of the tentative Addendum. The tentative Addendum will be presented to the Regional Board for adoption at their regularly scheduled meeting on August 16, 2006. If adopted, the tentative Addendum will authorize the discharge of treated effluent from the new Southern Region Tertiary Treatment Plant to the Oceanside Ocean Outfall.

The final deadline for submittal of written comments, however, is August 9, 2006. Per Regional Board direction, written material submitted to the Regional Board office after the submittal deadline date will not be provided to the Regional Board. Also, it is not likely that written material will be accepted by the Regional Board on the day of the meeting.
