SUBJECT: NOTICE OF VIOLATION: FAILURE TO SUBMIT ANNUAL REPORT REQUIRED BY THE GENERAL INDUSTRIAL STORM WATER PERMIT ORDER NO. 97-03-DWQ, NPDES PERMIT NO. CAS000001

You are in violation of the statewide General Industrial Storm Water Permit, Order No. 97-03-DWQ (Order) for failure to submit your 2004-2005 Annual Report. The report was due at the California Regional Water Quality Control Board, San Diego Region (Regional Board) office by July 1, 2005 as required by Section B.14 of the Order.

Pursuant to Sections 13399.33 and 13385 of the California Water Code (CWC), failure to submit the annual report subjects you to possible enforcement action by the Regional Board, including assessment of administrative civil liability. Civil liability could range from a minimum of \$1,000 and up to \$10,000 a day for each day of violation, if the liability is assessed administratively by this Regional Board, or up to \$25,000 a day, if the liability is assessed by a court; you may also be subject to criminal prosecution under Section 13387 of the CWC. The number of days of violation for failure to submit the 2004-2005 Annual Report would be counted from July 2, 2005, up to the date the 2004-2005 Annual Report is submitted.
