TENTATIVE ORDER NO. R9-2007-0148; WASTE DISCHARGE REQUIREMENTS FOR THE CALIFORNIA DEPARTMENT OF TRANSPORTATION TECATE TRUCK INSPECTION STATION

Enclosed is a copy of Tentative Order No. R9-2007-0148, including Monitoring and Reporting Program, which Regional Board staff intends to present to the Regional Board for adoption at their regularly scheduled meeting on December 12, 2007.

If adopted, the tentative Order would establish waste discharge requirements for the California Department of Transportation (Caltrans) for the discharge of up to 550 gallons per day of domestic wastewater and sump wastewater from the truck inspection bays to a conventional septic tank/leach field system at the Tecate Truck Inspection Station.


The Regional Board would like to point out the following areas in the tentative Order:

- 1. Discharge Specifications have been established for groundwater monitoring wells downgradient of the leach field.
- The Monitoring and Reporting Program requires monitoring of the effluent discharged to the leach field, the sump wastewater prior to discharge to the septic tank, and for groundwater upgradient and downgradient of the leach field.
