- SUBJECT: Modification of Waste Discharge Requirements: Skyline Ranch Country Club, Recycled Water Project (tentative Addendum No. 1 to Order No. R9-2005-0258) (*Robert Morris*)
- PURPOSE: To adopt tentative Addendum No. 1 to Order No. R9-2005-0258 (Supporting Document No. 2), An Addendum Prescribing Requirements for the Discharge and Use of Recycled Water for Landscape Irrigation at Skyline Ranch Country Club, San Diego County.
- PUBLIC NOTICE: Notification of this action was posted on the Regional Board web page on September 17, 2008. This notification satisfies the requirements of California Water Code section 13167.5 for a 30-day notice.
- DISCUSSION: Skyline Ranch Country Club, LLC (SRCC) submitted a Report of Waste Discharge, requesting modification of Order No. R9-2005-0258 to prescribe requirements for the discharge of up to 0.045 million gallons per day (MGD) of disinfected tertiary recycled water and its use for landscape irrigation of the golf course at their facility. Currently, SRCC discharges up to 0.030 MGD of undisinfected secondary recycled water to a 15-acre field that has restricted access to the public.

SRCC is a golf course community in Valley Center, which has been in existence since 1973. The community consists of 220 residential mobile home units and a 9-hole golf course. SRCC has during this past year upgraded its wastewater treatment plant to provide tertiary treatment. The upgrade included converting the activated sludge process to a membrane bioreactor (MBR) system that utilizes membrane filtration in place of clarification, installing of a chlorine disinfection unit, and constructing an emergency storage facility.

Tentative Addendum No.1 (Supporting Document 2) revises Order No. R9-2005-0258 to prescribe applicable requirements for the treatment of domestic sewage for its use as recycled water for landscape irrigation. These requirements are consistent with the California Department of Public Health's (CDPH) conditions of approval that have been submitted in accordance with the
