- SUBJECT: REQUEST FOR CLEANUP AND ABATEMENT ACCOUNT FUNDS FOR SAN DIEGO BAY SHIPYARD SEDIMENT SITE ENVIRONMENTAL IMPACT REPORT

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is seeking funding from the Cleanup and Abatement Account (CAA) to retain a qualified environmental consultant to prepare an environmental impact report (EIR) for the tentative Cleanup and Abatement Order for the Shipyard Sediment site in San Diego Bay. The proceedings on the CAO were referred to confidential mediation by Board Chair David King in June 2008. Through the course of the mediation the responsible parties and the San Diego Water Board Cleanup Team reached agreement on appropriate cleanup levels, the preliminary remedial design, remediation and post-remediation monitoring requirements, and a remedial action implementation schedule.

Before the San Diego Water Board can adopt tentative Cleanup and Abatement Order No. R9-2011-0001 an EIR must be prepared and certified. Unfortunately, the responsible parties have failed to reach agreement on allocation of the costs of preparing the EIR, necessitating this request for funding for the EIR from the CAA. As the funds will be used for environmental consultation on a cleanup and abatement order, in the event the tentative CAO is adopted by the San Diego Water Board and upheld after all appeals, pursuant to authority granted in Water Code section 13304, the San Diego Water Board intends to recover the funds from the responsible parties.

Preparing and certifying the EIR is the critical path for adoption of this important CAO. I would greatly appreciate your Division's expedited processing of this request. I would also request that at the earliest opportunity, this item be placed on the State Water Resources Control Board's agenda for consideration.
