The tentative conditional waivers issued through the adoption of the Tentative Order will require the implementation of effective management measures, and structural and non-structural best management practices to address potential impacts associated with storm water run on and runoff, wastes, and wastewaters discharged from facilities or operations located within the San Diego Region. The workshop is scheduled for:

At the workshop, staff will give an overview of the Tentative Order and receive your comments and questions. Staff would like to hear comments about the Tentative Order and ideas for its improvement. A quorum of Board members may be present at the workshop but no action will be taken.

Background

The San Diego Water Board is required to protect the quality and beneficial uses of the waters of the State, and is developing revised *Conditional Waivers of Waste Discharge Requirements for Low Threat Discharges in the San Diego Region*. The Water Code provides the San Diego Water Board the authority to waive the requirements to issue waste discharge requirements provided the waiver is consistent with the *Water Quality Control Plan for the San Diego Region* (Basin Plan) and is in the public interest. The most recent set of conditional waivers adopted by the San Diego Water Board through Resolution No. R9-2007-0104 expired in February 2014. If adopted by the San Diego Water Board, the Tentative Order will replace the waivers adopted by the San Diego Water Board in 2007.
