## CALIFORNIA REGIONAL WATER QUALITY CONTROL BOARD SAN DIEGO REGION

#### NOTICE OF PUBLIC HEARING AND WRITTEN COMMENT PERIOD

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing Tentative Order No. R9-2018-0006, *An Order Rescinding Orders Nos 93-27 and R9-2007-0046* (Tentative Order) for public review and comment. The San Diego Water Board will consider adoption of the Tentative Order at its regularly scheduled meeting on **April 11, 2018**. The Tentative Order, if adopted, will rescind:

- Order No. 93-27, Waste Discharge Requirements for Lilac Enterprise Corporation, Hideaway Lake Mobile Estates, San Diego County; and
- Order No. R9-2007-0046, Waste Discharge Requirements for Oak Tree Ranch Inc., Oak Tree Ranch Private Residential Community, San Diego County.

#### Background

The Tentative Order, if adopted, would rescind Waste Discharge Requirements (WDRs) for wastewater treatment systems at the *Hideaway Lake Mobile Estates* and *Oak Tree Ranch Private Residential Community*. The discharges from the onsite wastewater treatment systems (OWTS) located at each of the facilities will be enrolled in State Water Resources Control Board Order No. WQ 2014-0153-DWQ, *General Waste Discharge Requirements for Small Domestic Wastewater Treatment Systems*.<sup>1</sup>
