NOTICE OF PUBLIC HEARING AND WRITTEN COMMENT PERIOD

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing Tentative Order No. R9-2018-0031, *An Order Rescinding Order No. 87-61* (Tentative Order) for public review and comment. The San Diego Water Board will consider adoption of the Tentative Order at its regularly scheduled meeting on **April 11, 2018**. The Tentative Order, if adopted, will rescind:

 Order No. 87-61, Waste Discharge Requirements for the California Department of Forestry, La Cima Conservation Camp, San Diego County.

Background

The Tentative Order, if adopted, would rescind Waste Discharge Requirements (WDRs) for the wastewater treatment facility (Facility) at the *La Cima Conservation Camp*. The discharges from the Facility will be enrolled in State Water Resources Control Board Order No. WQ 2014-0153-DWQ, *General Waste Discharge Requirements for Small Domestic Wastewater Treatment Systems*.¹
