NOTICE OF PUBLIC HEARING FOR 2018 BASIN PLAN TRIENNIAL REVIEW

Triennial Review of the Basin Plan

The Basin Plan review is sometimes referred to as the "triennial" review because federal law requires a review of water quality standards every three years. The *Water Quality Control Plan for the San Diego Basin* (Basin Plan) contains the water quality standards applicable within the San Diego Region, and periodic review and update of the Basin Plan is required by state and federal laws.

The purpose of the review is to identify and prioritize possible revisions to water quality standards and other aspects of the <u>Basin Plan</u>. The result of the review is a list of priority projects to be investigated further and, where appropriate, addressed through the adoption of Basin Plan amendments.

A public hearing to consider adoption of a prioritized list of projects and to conclude the 2018 Triennial Review will be held during the San Diego Water Board meeting scheduled for:

This item will be heard during the board meeting that starts at **9:00 a.m**. Public Participation

Written comments on a preliminary issues list provided by the San Diego Water Board, or on other suggestions for revisions to the Basin Plan were invited during a 54-day comment period from March 23, 2018 to May 16, 2018. A public workshop to provide information and to hear comments was held on May 9, 2018, during a regularly scheduled meeting of the San Diego Water Board. A draft prioritized list of proposed projects to revise the Basin Plan was made available on June 22, 2018. The proposed projects included: Tijuana River Valley Water Quality Restoration, Biological Objectives for Water Bodies in the San Diego Region, Contact Water Recreation (REC-1) Water Quality Objectives, Climate Change Readiness: Sustainable Local Water Supply, Clean Water Action Section 304(a) Criteria Recommendations, and Editorial Revisions, Minor Clarifications or Corrections. The public was invited to submit comments on the draft prioritized list during a 45-day public comment period from June 22, 2018 to August 6, 2018.
