- 2. Chairman's, Board Members', State Water Board Liaison's, and Executive Officer's Reports. These items were for Board discussion only. Public testimony was not allowed, and the Board took no formal action.
  - Ms. Cantú reported that the Chair has appointed a committee consisting of Dr. Olson, Mr. Strawn, and Ms. Cantú to investigate the use of modern technologies that would enhance the Board's monitoring capabilities, given limited resources and dealing with the COVID-19 situation.
  - Ms. Firestone stated that the Governor's May Budget Revise is expected in the next couple of days; she indicated that, as the State and Regional Water Boards are fee-funded, we are in a slightly better position than those agencies that rely on the General Fund. She also provided an update on State Board activities and priorities for upcoming meetings, and she responded to Board Member questions.
  - Mr. Gibson introduced new staff members, Lark Starkey and Lara Quetin. He reported that under the USMCA trade agreement \$300 million has been allocated for addressing issues in the Tijuana River Valley, and that there will be a USEPA public stakeholder meeting on or about June 2, 2020. Dr. Abarbanel asked that the Board Members be notified when that date is finalized.
  - Mr. Anderson offered to help Water Board staff in the revisions to the Irrigated Lands Orders.
  - Mr. Gibson then responded to Board Member questions and comments.
