Notice is hereby given that the San Diego Water Board will accept written comments regarding the Tentative Order in accordance with this notice and pursuant to Water Code section 13167.5.

The written comment period provides an opportunity for interested persons to comment on the Tentative Order. All written comments regarding the Tentative Order must be received no later than **5:00 p.m. on Monday, April 24, 2023**, to be considered by the San Diego Water Board. The early submission of written comments on the Tentative Order is encouraged. Written comments received by **5:00 p.m. on Monday, April 24, 2023**, will be provided to the San Diego Water Board members for their review in advance of the public hearing to consider adoption of the Tentative Order. The San Diego Water Board will prepare written responses to significant comments that are timely received. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Monday, April 24, 2023**, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
