The San Diego Water Board will consider adoption the Tentative Order at its regularly scheduled meeting on **March 8, 2023**. The Tentative Order, if adopted, will rescind Order No. 94-93, *Waste Discharge Requirements for the County of San Diego, Potrero Park, near Potrero*.

All written comments regarding the Tentative Order must be received no later than **5:00 p.m. on Monday, January 9, 2023**, to be considered by the San Diego Water Board. The early submission of written comments on the Tentative Order is encouraged. Written comments received by **5:00 p.m. on Monday, January 9, 2023**, will be provided to the San Diego Water Board members for their review in advance of the public hearing to consider the adoption of the Tentative Order. The San Diego Water Board will prepare written responses to significant comments that are timely received.

Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Monday, January 9, 2023**, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
