REVISED NOTICE OF OPPORTUNITY TO COMMENT FOR TENTATIVE CEASE AND DESIST ORDER NO. R9-2023-0129

PINE HILL EGG RANCH AND DEMLER BROTHERS' PULLET FARM

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) will consider the adoption of Tentative Cease and Desist Order No. R9-2023-0129 (Tentative CDO) issued to Demler Brothers LLC, Kevin Demler, and Alex Demler (collectively, Dischargers). If adopted, the Tentative CDO directs the Dischargers to immediately cease and desist from discharging and threatening to discharge wastes from the Pine Hill Egg Ranch (Facility) located at 25818 State Route 78, Ramona, San Diego County, and the Demler Brothers' Pullet Farm (Pullet Farm) located at 24555 Old Julian Highway in Ramona, San Diego County. A public hearing and a date for consideration of the Tentative CDO is forthcoming and will be announced separately.

Based on the facts presented in the Tentative CDO, the Prosecution Team finds that the Dischargers' waste-generating activities at the Facility and Pullet Farm, including confined animal feeding operations, egg washing, and onsite composting, pose a significant and ongoing threat to Santa Teresa Valley Creek, Hatfield Creek, and the Santa Maria Groundwater Basin. The waste discharges from these activities are in violation of Title 40 of the Code of Federal Regulations, the California Water Code, discharge prohibitions of the Water Quality Control Plan for the San Diego Basin, and the Industrial General Stormwater Permit.

If adopted, the Tentative CDO would, in accordance with California Water Code sections 13267, 13301, and 13303, require the Dischargers to immediately cease and desist from discharging and threatening to discharge waste until the Dischargers complete corrective actions related to waste management and disposal according to a time schedule. Finally, the Tentative Order requires the Dischargers to seek the necessary regulatory coverage for the waste discharges. Failure to comply with the deadlines specified in the CDO would be subject to administrative civil liability.
