The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing for public review and comment, Tentative Order No. R9-2026-0001, *Amending Order No. R9-2010-0032, Waste Discharge Requirements and Master Reclamation Permit for the City of Escondido, Hale Avenue Resource Recovery Facility and Order No. R9-2023-0131, Waste Discharge Requirements for the City of Escondido Membrane Filtration and Reverse Osmosis Facility* (Tentative Order). The Tentative Order, if adopted, will remove the color effluent limitation and monitoring requirement from Order Nos. R9-2010-0131 and R9-2023-0131.
